#### Class E: Commercial, business and service uses

- Shop
- Financial and professional services (excluding medical)
- Café or restaurant
- Office other than a use within a Class A2
- Research and development of products or processes
- For any kind of industrial process (which can be carried out in any residential area without detriment to the amenity of the area)
- Clinics, health centres, crèches, day nurseries and day centres
- Gymnasiums, indoor recreations not involving motorised vehicles or firearms

#### Class F1: Learning and non-residential institutions

 Hall or meeting place for the principal use of the local community

#### Sui Generis: In a class of its own

- Pub or drinking establishment
- Take away
- Cinemas, concert halls, bingo halls and dance halls

#### **Class F2: Local community uses**

- Shop not more than 280sq m mostly selling essential goods, inc.
  food and at least 1km from another similar shop
- Indoor or outdoor swimming baths, skating rinks, and outdoor sports or recreations not involving motorised vehicles or firearms
